TERMS OF SERVICE

FEES AND DEPOSIT

Bespoke Vows (BV)

All services are tailored to fit the Client's needs. Exception: Officiant services only, fees begin at \$975.00. Full payments for Services are due upon booking. Initial payments are non-refundable, and applied against Services rendered.

FORMS OF PAYMENT

REIMBURSEMENT OF EXPENSES

Client may cancel any Service (other than Officiant Services) at any time, but the initial deposit is non-refundable.
